## **Executive Summary**

The balance after dues collections and 2020 expenses \$299,976.65. Income to the society, due to exclusively member dues was \$10,961.00. No income was generated from levies as no conferences were held during 2020.

Total expenses amounted to \$5,770.49 with a credit of \$1,368.21. Expenses were well below the operating budget of \$18,420.00. A successful effort was made in maintaining CIGR expenses below the income generated by member dues.

State and federal reports and tax declarations were submitted.

## Background.

Per CIGR Statutes CIGR auditors are charged with:

- 1. Yearly control of the financial management of CIGR,
- 2. comment on budgeting with an outlook towards future financing, and to

3. report on these two items to the Executive Board yearly and to the General Assembly per biennium in proper time for approval.

The Secretary General, acting as Treasurer, assists the Auditors.

The office of the Secretary General operates from a budget approved by the Presidium with oversight from the auditors. Per CIGR Statute allowable expenses include:

- 1. Administration costs of the General Secretariat.
- 2. General costs for the meetings of the General Assembly, the Executive Board, the Presidium and the Technical Board.
- 3. Specific costs of representation.
- 4. Payment for member service materials.
- 5. Specific costs of WG's and ad hoc committees.
- 6. Publication of reports, handbooks, electronic journals and newsletters.
- 7. Travel expenses for the General Secretariat.
- 8. Costs of the Website.
- 9. Other legal expenses.

This report focuses the 2020 expenses of CIGR.

#### 2019 Audit

Expenses related to the operation of CIGR for 2019 were approved by the Presidium and the CIGR auditors. The report was accepted by the CIGR Executive Board during the 2020 International Conference held online via Zoom.

## CIGR Federal Tax and State Report

Starting 2018 the firm LegalZoom was hired to assist the current Secretary General in the incorporation of CIGR in the State of Florida as a Tax-free legal entity. After preparation of the necessary documentation CIGR was officially incorporated under the Division of Corporations, Florida Department of State on August 15, 2018 at 5:00 PM. The official name of CIGR under the law is "CIGR: International Commission of Agricultural and Biosystems Engineering Corporation". The official physical address of the Corporation is Rodger Hall 169, University of Florida, Gainesville, FL 32611 USA. Officers in the corporation are the members of the Presidium.

## 2020 Expense Accounting

Table 1 below summarizes CIGR bank monthly account statements. The 2019 Closing balance was \$293,706.16. The 2020 closing balance is \$299.976.65.

The beginning Balance as of January 1, 2020 was \$293,706.16. With deposits due to dues of \$10,961.00, and a total of expenses of \$5,690.51 resulting in an ending balance of \$299,976.65. Subtractions and Additions to the account are summarized for the remaining months in Table 1.
